#### REPORT OF THE COUNTY EXECUTIVE

On April 3, 2018, the Onondaga County Legislature passed a local law purporting to clarify authorization for the Legislature's Chairman to hire and use counsel under the Onondaga County Charter and Administrative Code, as drafted.

But where is this authority stated?

Not in the Charter. Not in the Administrative Code.

The Charter and Administrative Code establish a system of checks and balances. Officers are empowered to perform differing roles, each toward advancing a County Government to provide services in an efficient, economical, and responsible manner.

The express text of these documents designates the County Attorney to represent the County's interests, not those of a specific officer or employee. (Administrative Code §7.06) Within Charter Section 702, the County Attorney "shall be the sole legal advisor for the county." (See also Administrative Code Section 7.02(a))

The County Attorney provides legal advice to all county officers and employees, assuming that the interest of such individuals is aligned with the County. Further, legislation is to be drafted, together with preparation of papers and legal instruments, in connection with such advice "where in the interest of the county". (Charter §702) Such documents may be requested by the County Executive or individual legislators. (Administrative Code §7.02)

The County Attorney is authorized to "retain special counsel [...] as may be deemed necessary in the performance of the duties of the office." (Administrative Code §7.05) No other individual is given authority, express or implied, to retain counsel.

Under what circumstances are individual officers and employees given the ability to have special retained counsel represent individual interests?

When conflicts of interests arise (or may foreseeably arise) in connection with a civil action or proceeding. When individuals have (or are alleged to have) interests misaligned with the County. When officers or employees act (or are alleged to have acted) outside the scope of their duties. When officers impermissibly set (or are alleged to have set) policies that are not the County's policies. In such cases, the use of retained counsel is authorized because of the existence of conflicts. The County Attorney continues to represent the County.

Such procedure is found outside the Charter and Administrative Code, codified by resolution within the County's policy of defense and indemnification. (Resolution No. 168-1990, as amended, consistent with Public Officers Law §18) An individual officer or employee does not have an opportunity to choose to retain outside counsel and not use the County Attorney's office in the absence of a conflict.

Even without the local law in place, the Legislature, as a body, employs counsel. A position exists within the Legislature's roster titled "Legislative Counsel". Contracts have been executed with various firms, consistent with resolutions adopted by the Legislature and within appropriations. Such counsel's services are to be coordinated by the County Attorney on behalf of the County.

Elected officials are stewards of the governance structure in which such officials serve. Changes in such governance structure should enhance accountability and transparency to foster public confidence in the integrity, competence, and independence of elected officials. Less transparent are the various ways in which political power is wielded outside of the open, public systems. Allowing a proliferation of counsel to be used, developing political strategy, funded by local taxpayer dollars, does not protect the public where such communication can be had cloaked under the cover of privilege.

Having a single client, the County, the County Attorney is ethically bound to provide representation in a manner consistent with the Rules of Professional Conduct. The representation involves the use of discretion and exercise of professional judgment. Interjecting competing legal opinions from retained counsel interferes with the County Attorney's effective representation, effecting a disservice to the public.

Further, the text of the local law as passed by the County Legislature contains legally significant errors, including, by way of example, language to be added to Section 7.02 of the Charter. No such section exists in that document. The local law was not drafted by the County Attorney (or his office). The County is best served by professionals who are both expert in municipal legal areas and experienced in routinely preparing legislation.

I hereby disapprove and veto the adoption of the local law passed on April 3, 2018, as it is not in the best interests of Onondaga County's citizens. This is not good governance.

## LOCAL LAW NO. - 2018

A LOCAL LAW AMENDING THE ONONDAGA COUNTY CHARTER AND ADMINISTRATIVE CODE TO PROVIDE CLARIFICATION AND GUIDANCE RELATED TO THE COUNTY LEGISLATURE'S AUTHORITY TO HIRE OUTSIDE COUNSEL TO PROVIDE LEGAL SERVICES, INCLUDING THE PREPARATION OF LOCAL LAWS, ORDINANCES, RESOLUTIONS, LEGALIZING ACTS OR OTHER LEGISLATION

BE IT ENACTED BY THE COUNTY LEGISLATURE OF THE COUNTY OF ONONDAGA, AS FOLLOWS:

Section 1. Findings.

WHEREAS, the Onondaga County Charter states that the County Attorney is the "sole legal advisor of the county" and for county officers and employees; and

WHEREAS, the Onondaga County Administrative Code states that the County Attorney shall "prepare local laws, ordinances, resolutions, legalizing acts or other legislation upon request of the County Executive or a member of the County Legislature, together with notices and other documents in connection therewith"; and

WHEREAS, there may be unique situations where the County Legislature, through its Chairman, determines that the County Attorney, who is appointed by, and serves at the pleasure of the County Executive, may have competing interests in preparation of local laws, ordinances, legalizing acts or other legislation; and

WHEREAS, it is the desire of the County Legislature to make it clear that the Charter and the Administrative Code as drafted authorizes the Chairman to consult with and use outside counsel to provide the County Legislature with legal advice, including the preparation of local laws, ordinances, legalizing acts or other legislation; now, therefore be it

RESOLVED, that the following local law shall be enacted:

Section 2. Outside Counsel.

(a) Article VII, Section 702 of the Charter is amended to add the following italicized language:

Section 702. POWERS AND DUTIES.

Except as otherwise provided in this charter, or the administrative code, the county attorney shall be the sole legal advisor for the county and, on its behalf in county matters of a civil nature, advise all county officers and employees and, where in the interest of the county, prepare all necessary papers and written instruments in connection therewith; prosecute or defend all actions or proceedings of a civil nature brought by or against the county; prepare resolutions, ordinances, legalizing acts and local laws to be presented for action by the board of supervisors, together with notices and other items in connection therewith; and perform such other and related duties as may be prescribed by law, by the county executive or by resolution of the board of supervisors. Nothing contained herein shall prohibit the Chairman of the County Legislature from using outside counsel or a specifically designated Legislative Counsel to provide legal assistance, including, but not limited to, the preparation of resolutions, ordinances, legalizing acts and local laws to be presented

for action by the County Legislature, the successor in interest of the board of supervisors. Such outside counsel or specifically designated Legislative Counsel may seek the advice of the county attorney as to form and legality in the preparation of resolutions, ordinances, legalizing acts and local laws.

#### Section 3.

- (a) Article VII, Section 7.02 of the Charter is amended to add the following subsection (f):
  - (f) Nothing contained herein shall prohibit the Chairman of the County Legislature from using outside counsel or a specifically designated Legislative Counsel to provide legal assistance, including, but not limited to, the preparation of resolutions, ordinances, legalizing acts and local laws to be presented for action by the County Legislature. Such outside counsel or specifically designated Legislative Counsel may seek the advice of the county attorney as to form and legality in the preparation of resolutions, ordinances, legalizing acts and local laws.

### Section 4. Severability.

If any clause, sentence, paragraph, section or part of this local law shall be adjudged by a court of competent jurisdiction to be invalid, the judgment shall not affect, impair or invalidate the remainder hereof, but shall be confined in its operation to the clause, sentence, paragraph, section of part thereof directly involved in the controversy in which the judgment shall have been rendered.

Section 5. Effective Date.

This local law shall be effective immediately upon filing, consistent with the provisions of the Municipal Home Rule Law.

My name is <u>Sandra Gowing</u> and I am a retired nurse. I want to thank Peggy Chase for submitting this resolution in support of the New York Health Act, which would give affordable health care to all New Yorkers. I am fortunate to always have had good health insurance. Many others are not as fortunate and are shut out of our health care system due to the lack of or inadequate insurance. Policies can be very expensive, even with subsidies and many have high deductibles.

A family member of mine was diagnosed with cardiomyopathy several years ago when he was only in this 30s. He was receiving treatment for this condition when he lost his job and his health insurance. He went without medical care for 5 years until the VA began admitting veterans without service related injuries but who have low incomes. By the time he received medical attention, his condition had greatly worsened and he required a pacemaker.

He has received good care and is now doing well. He gets affordable medications through the VA pharmacy. He is among the fortunate as many others continue to fall through the cracks, with incomes too low to afford insurance and medical care, but not low enough to qualify for Medicaid.

I recently learned that One-third of Americans are unable to access medical care because of cost.

I have been a practicing primary care doctor for years in Syracuse and I have witnessed this firsthand.

In my office, I have spent hours of frustration dealing personally with insurance companies in an attempt to help obtain coverage for my patients.

The entire framework for coverage is in direct opposition to providing good care, creating excessive waste in the time that I myself and my office staff spends on the phone arguing with insurance companies.

At a whim, insurance will deny coverage of medications, or deny preventive visits.

Patients who do not qualify for assistance often go without medications they need, or delay getting exams and tests that could detect diseases - like cancer - in the earliest stages.

The New York Health Plan would greatly improve the ways in which I can deliver care to my patients. By reducing waste and fraud, time in my office could be better spent in direct patient care.

By reducing drug and device prices, my patients could afford the medications they need for their high blood pressure and could purchase the devices such as nebulizers or cpap machines that they need for their respiratory illnesses.

By making coverage available to everyone we could be using preventive services more effectively..., before patients end up in our overcrowded emergency rooms in crisis.

And With the New York Health Act, New York State is expected to see drastic, significant savings \$45 billion per year.

It is incredible and unethical to me that this is not already being done.

I wholeheartedly support the New York Health Act and I urge you to do the same.

Making the change to comprehensive universal health coverage for all is the right thing to do for patients, for doctors, for offices, and for New York State.

# THE NEW YORK HEALTH ACT SAVES COUNTIES BILLIONS BY ELIMINATING LOCAL CONTRIBUTIONS TO MEDICAID

#### **COUNTY GOVERNMENT PAYMENTS FOR MEDICAID**

Medicaid, a program typically funded by federal and state governments, is uniquely financed in New York State by payments from counties. While the State is capping these county payments, in 2015 they still amounted to 15% of the total cost of Medicaid in New York. In total, \$7.8 billion was levied from county governments across the state in 2015, forcing cash-strapped counties to assess property taxes at some of the highest levels in the nation. Some upstate and western New York counties, such as Erie, spend as much as 85% of property tax revenue on Medicaid. New York City contributed over \$6.4 billion to Medicaid in 2015 equivalent to nearly 10% of its total spending! Check out the table on the reverse side of this page to see what your own county now spends on Medicaid.

#### WHAT WILL THE NEW YORK HEALTH ACT DO?

The New York Health Act would "[end] the requirement for local social services districts to pay part of the cost of Medicaid and replacing those payments with revenue from the assessments under the [New York Health] revenue proposal." This simultaneously terminates county Medicaid payments while providing Medicaid beneficiaries (and everyone else!) with better, more comprehensive coverage.

#### WHO WILL BENEFIT?

Together, "downstate suburban counties would save over \$1 billion, upstate cities over \$600 million, and rural areas and elsewhere \$1.3 billion." And New York City would save around 10% of its current spending. Clearly, the taxpayers in each of these jurisdictions would see substantial savings on their property taxes and other taxes and fees.

#### Conclusion:

Onondaga County would have reduced medical expense from \$73,022,333 (7.17% of budget) to \$7,904,619(0.77% of budget).

The county Medicaid mandate of \$100,133,000 would have been eliminated. (This amount equaled 71.6% of the 2016 County tax levy.)

That would have meant total 2016 savings of about \$165.2 million.

Ruth Heller talking points for NY Health Act, May 1, 2018:

My name is <u>Ruth Heller</u> and I am the Executive Vice-President of 1199SEIU, United Healthcare Workers East, representing over 22,000 healthcare workers across Central, Northern and Western NY. Our workers are on the front lines of providing quality care that affects us all as a community, no matter where we live, learn or work. I speak today in favor of the New York Health Act. We unequivocally support the aim of the NY Health Act to provide comprehensive, universal health coverage for every New Yorker. A single-payer plan would eliminate administrative waste and allow for precious resources to be invested in the provision of health care for our State's residents.

The New York Health Act, which would create a state-run Medicare-style single-payer system, now has 30 co-sponsors in the state Senate and has passed the NYS Assembly. Our community, and specifically our healthcare institutions would benefit from the passage of this legislation. Our union has been focused on New York State's response to Federal changes in the way healthcare is funded. We expect a number of defensive battles to come, including over continuing cost-sharing subsidies and the Medicaid budget. Hospitals, nursing homes, and home health agencies in our area rely on funding from these revenue sources. Passage of the New York Health Act would ensure that our institutions have the resources necessary to deliver the highest quality care, and the residents of our community will not have to choose between paying various bills in order to cover their personal healthcare costs. It makes sense from a financial standpoint, a healthcare delivery system standpoint, and a social justice standpoint. We all deserve affordable, quality healthcare.

I stand here not only as a leader of healthcare workers, but as a Labor leader serving on the board of our Area Labor Federation. More than 40 unions and labor groups have endorsed the bill. They include the New York State AFL-CIO, 1199SEIU, Communications Workers of America District 1 and several locals, International Association of Machinists District 15, two locals of the International Association of Theatrical and Stage Employees, Teamsters Joint Council 16, the Long Island Federation of Labor, United Auto Workers Regions 9 and 9A, New York State United Teachers and United Federation of Teachers Local 2, and both the Central and Western New York Area Labor Federations. There is broad support for this bill.

We are asking you as the Legislature to reflect the popular will for this legislation. If the past few years has taught us anything, it's that people are demanding quality, affordable healthcare. The best way to deliver that is for New York State to pass the New York Health Act. Join the people in making this demand. Thank you, and Happy International Workers Day.

It will be a boon to our economy by allowing budding entrepreneurs to reinvest and grow their businesses, municipalities to redirect employee healthcare costs into the community and doctors to use their time on patients instead of insurance claims.

Ladies and Gentlemen of the County Legislature, I urge you to send an unequivocal message to our state leaders. New Yorkers cannot wait for Washington to act. We insist on a compassionate healthcare system that does not discriminate and will no longer keep millions in fear of getting ill or falling into poverty due to illness. We need our state leaders to safeguard our future by passing the one piece of legislation that could have the greatest positive impact on the NYS economy and the lives of our residents - the NYS Health Act. 

## MEMORIALIZING THE GOVERNOR AND THE LEGISLATURE OF THE STATE OF NEW YORK TO ADOPT THE NEW YORK HEALTH ACT

WHEREAS, every person in New York State deserves access to affordable, quality health care; and

WHEREAS, according to an analysis by economic professor Gerald Friedman in 2015, the average cost of an employer-provided family health plan in New York State is over \$17,500 with an average family deductible of over \$2,200; and

WHEREAS, according to the analysis, the share of state income spent on health care and the administration of the health care system will rise to 18 percent by 2024, much faster than incomes are rising; and

WHEREAS, New Yorkers are experiencing this rapid rise in the cost of health care and coverage in recent years, resulting in large numbers of people without coverage, and many more severely underinsured; and

WHEREAS, this Onondaga County Legislature believes that controlling rising health care costs and ensuring health care for all residents are of paramount importance; and

WHEREAS, to address the fiscal crisis facing the health care system, and to ensure that New Yorkers can exercise their right to health care, New York State should adopt a single payer system introduced in the New York State Legislature, commonly known as the New York Health Act; and

WHEREAS, the New York Health Act would replace the current multi-payer system of employer-based insurance, individually-acquired insurance, and federally sponsored programs, with a comprehensive single-payer health care coverage program, which would result in 98% of New York households paying less for health care than they do now; and

WHEREAS, the New York Health Act would be funded by progressively-graduated assessments based on ability to pay, including a progressively graduated state payroll tax, a surcharge on upper bracket non-employment income (e.g. interest, dividends, capital gains), and rollover of Federal funds formerly paid by Medicare, Medicaid, Family Health Plus and Child Health Plus programs; and

WHEREAS, the New York Health Act would pool all health revenue sources (e.g., assessments, federally-matched public health programs, Affordable Care Act subsidies) into a dedicated New York Health Trust Fund to pay providers directly; and

WHEREAS, the New York Health Act will reduce healthcare costs for government, businesses and individuals, by reducing billing expenses, administrative waste, anticompetitive pricing of drug and medical devices, with an estimated net saving of \$45 billion per year from current healthcare costs; and

WHEREAS, the New York Health Act would provide all medically necessary care, including medical, prescription, vision, dental, hearing, mental health and substance abuse treatment under one comprehensive plan, while retaining an individual's freedom of provider choice; and

WHEREAS, the New York State Assembly has already passed the New York Health Act under Assembly Bill A.4738, in 2015, 2016 and 2017; and

WHERAS, a companion bill was introduced in the New York State Senate, Senate Bill S. 4840A; now, therefore be it

RESOLVED, that this Onondaga County Legislature hereby requests the New York State Senate and the Governor of the State of New York to adopt S. 4840A, the New York Health Act, to provide affordable, high quality, comprehensive health care for all New Yorkers, with access to medical services and providers of their choice, without regard to age, income, health, employment or immigration status; and, be it further

RESOLVED, that the Clerk of this Legislature is hereby directed to transmit a copy of this resolution to the New York State Governor and to the State Legislators representing Onondaga County.



WHEREAS, as presently Rule 8 of the Rules of the Onondaga County Legislature requires approval as to form and legality by the County Attorney of every petition, resolution, local law, ordinance, and amendment prior to its presentation before the County Legislature; and

WHEREAS, there may be unique situations where the County Legislature, through its Chairman, determines that the County Attorney, who is appointed by, and serves at the pleasure of the County Executive, may have competing interests in preparation of local laws, ordinances, legalizing acts or other legislation; and

WHEREAS, the County Legislature is considering an amendment to the Onondaga County Charter and the Onondaga County Administrative Code to make it clear that the Chairman of the County Legislature has authority to consult with and use outside counsel to provide the County Legislature with legal advice, including the preparation of local laws, ordinances, legalizing acts or other legislation; and

WHEREAS, Rule 8 of the Rules of the County Legislature states that:


"All petitions, resolutions, local laws, ordinances and reports of Committees and communications shall be in writing and read by the Clerk of the County Legislature or by a person designated by the Clerk, and shall be filed with the Clerk of the County Legislature not later than 11:00 o'clock a.m. of the Monday of the week preceding any regular meeting, and 11:00 o'clock a.m. three (3) days preceding any special meeting, or adjourned meeting. Amendments of the foregoing shall be presented to the County Legislature not later than 11:00 o'clock a.m. on the day of any regular, special, or adjourned meeting. The provisions of the foregoing in reference to filing of petitions, resolutions, local laws, ordinances, amendments thereto, reports of Committees and communications, may be waived by a majority vote of the County Legislature members present and voting. All petitions, resolutions, local law, ordinances and amendments thereto must be approved by the County Attorney as to form and legality and shall not be presented before this County Legislature until so approved."

WHEREAS, it is the desire of the County Legislature to conform Rule 8 to proposed local law to amend the Onondaga County Charter and Onondaga County Administrative Code to make it clear that in the event the Chairman of the Onondaga County Legislature determines that a conflict exists between the County Attorney and the County Legislature, or if it is in the best interest of the County Legislature, the Chairman may use outside counsel to draft petitions, resolutions, local laws, ordinances and amendments; now, therefore be it

RESOLVED, that Rule 8 of the Rules of the Onondaga County Legislature is hereby amended to read as follows:

"All petitions, resolutions, local laws, ordinances and reports of Committees and communications shall be in writing and read by the Clerk of the County Legislature or by a person designated by the Clerk, and shall be filed with the Clerk of the County Legislature not later than 11:00 o'clock a.m. of the Monday of the week preceding any regular meeting, and 11:00 o'clock a.m. three (3) days preceding any special meeting, or adjourned meeting. Amendments of the foregoing shall be presented to the County Legislature not later than 11:00 o'clock a.m. on the day of any regular, special, or adjourned meeting. The provisions of the foregoing in reference to filing of petitions, resolutions, local laws, ordinances, amendments thereto, reports of Committees and communications, may be waived by a majority vote of the County Legislature members present and voting. All petitions, resolutions, local law, ordinances and amendments thereto will be provided to the County Attorney for review and approval as to form and legality. Nothing contained herein shall prohibit the Chairman of the County Legislature, upon a finding by the Chairman that a conflict of interest may be present or that it is in the best interest of the County Legislature, from using outside counsel or a specifically designated Legislative Counsel to provide legal assistance, including, but not limited to, the preparation of resolutions, ordinances, legalizing acts and local laws to be presented for action by the County Legislature. Such outside counsel or specifically designated Legislative Counsel may, but are not required to, seek the advice of the County Attorney as to form and legality in the preparation of resolutions, ordinances, legalizing acts and local laws."

#### **BOND RESOLUTION**

A RESOLUTION AUTHORIZING THE RECONSTRUCTION OF COUNTY ROADS IN AND FOR THE COUNTY OF ONONDAGA, NEW YORK, AT A MAXIMUM ESTIMATED COST OF \$5,700,000, AND AUTHORIZING THE ISSUANCE OF \$5,700,000 BONDS OF SAID COUNTY TO PAY COSTS THEREOF

BE IT RESOLVED, by the affirmative vote of not less than two-thirds of the total voting strength of the County Legislature of the County of Onondaga, New York, as follows:

Section 1. The reconstruction of County roads, including sidewalks, gutters, drainage, landscaping, grading or improving rights-of-way and other improvements and costs incidental thereto, is hereby authorized in and for the County of Onondaga, New York, at a maximum estimated cost of \$5,700,000.

Section 2. The plan for the financing thereof is by the issuance of \$5,700,000 bonds of said County, hereby authorized to be issued therefor pursuant to the provisions of the Local Finance Law.

Section 3. It is hereby determined that the period of probable usefulness of the aforesaid class of objects or purposes is fifteen years pursuant to subdivision 20 of paragraph a of Section 11.00 of the Local Finance Law.

Section 4. The faith and credit of said County of Onondaga, New York, are hereby irrevocably pledged for the payment of the principal of and interest on such bonds as the same respectively become due and payable. An annual appropriation shall be made in each year sufficient to pay the principal of and interest on such bonds becoming due and payable in such year. To the extent not available from other sources, there shall annually be levied on all the taxable real property of said County a tax sufficient to pay the principal of and interest on such bonds as the same become due and payable.

Section 5. Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of the bonds herein authorized, including renewals of such notes, is hereby delegated to the Chief Fiscal Officer of such County. Such notes shall be of such terms, form and contents, and shall be sold in such manner, as may be prescribed by said Chief Fiscal Officer, consistent with the provisions of the Local Finance Law.

Section 6. All other matters except as provided herein relating to the bonds herein authorized including the date, denominations, maturities and interest payment dates, within the limitations prescribed herein and the manner of execution of the same, including the consolidation with other issues, and also the ability to issue bonds with substantially level or declining annual debt service, shall be determined by the Chief Fiscal Officer, the chief fiscal officer of such County. Such bonds shall contain substantially the recital of validity clause provided for in Section 52.00 of the Local Finance Law, and shall otherwise be in such form and contain such recitals, in addition to those required by Section 51.00 of the Local Finance Law, as the Chief Fiscal Officer shall determine consistent with the provisions of the Local Finance Law.

<u>Section 7</u>. The validity of such bonds and bond anticipation notes may be contested only if:

- 1) Such obligations are authorized for an object or purpose for which said County is not authorized to expend money, or
- 2) The provisions of law which should be complied with the date of publication of this resolution are not substantially complied with, and an action, suit or proceeding contesting such validity is commenced within twenty days after the date of such publication, or
- 3) Such obligations are authorized in violation of the provisions of the Constitution.

<u>Section 8</u>. The County Executive is authorized to enter into contracts to implement the intent of this resolution.

Section 9. This resolution shall constitute a statement of official intent for purposes of Treasury Regulations Section 1.150-2. Other than as specified in this resolution, no monies are, or are reasonably expected to be, reserved, allocated on a long-term basis, or otherwise set aside with respect to the permanent funding of the object or purpose described herein.

Section 10. This resolution, which takes effect immediately, shall be published in summary form in the Syracuse Post Standard, the official newspaper of said County, together with a notice of the Clerk of the County Legislature in substantially the form provided in Section 81.00 of the Local Finance Law.





# LOCALLY ADMINISTERED FEDERAL AID PROJECTS

The Onondaga County Department of Transportation is required to administer and oversee all Federal Highway Transportation funding used for highway purposes. Following is a list of projects in which the local matching share is being funded through this workplan.

A. <u>Bridge Maintenance Project, Phase II</u> This project has been modified and the Structural Steel of 3 bridges will be repaired and painted in order to keep them in a state of good repair.

This project in conjunction with the completed Bridge Maintenance I and Bridge Painting will help to keep County Bridges in good condition and extend the service life.

The Legislature previously authorized \$470,000 (\$94,000 County Share) for the design phase of the project as part of a multi-year funding plan. The estimate to construct the project currently stands at \$700,000 and is scheduled for a 2019 letting.

This project will be a "LOCALLY ADMINISTERED FEDERAL AID PROJECT" with a financial cost breakdown for Construction of 80% Federal, 15% State, 5% County.

B. Onondaga Lake Canalway Trail Extension – This project, in the Town of Geddes and the City of Syracuse, will extend the existing trail along Onondaga Lake to the Creekwalk in the City of Syracuse. A bridge will be constructed across the CSX Railroad tracks to extend the trail to Hiawatha Boulevard.

Improvements are proposed which will include all necessary safety and amenity features.

The estimate to construct the project stands at \$9,000,000. Additional Federal funding has been secured and has been included as part of this 2018 Workplan.

The Legislature previously authorized \$850,000 (\$170,000 County Share) for the design phase of the project and authorized \$3,500,000 (\$700,000 County Share) for the construction phase of the project as part of a multi-year funding plan.

This project will be a "LOCALLY ADMINISTERED FEDERAL AID PROJECT" with a financial cost breakdown for Construction of 80% Federal, 20% County. The Department will utilize OTASC Tobacco Funds to fund \$900,000 of the Local Share of this project.

C. <u>Bridge Painting</u>— This project, in the Towns of Pompey, Manlius, Salina, Marcellus and Elbridge, is an element specific work project involving the cleaning and painting of 6 steel bridges.

The various bridges were constructed or rehabilitated over a period of time ranging from 1951 to 2005, and show no major structural or functional problems. All of the bridges are steel multigirder structures with a structural concrete deck and integral wearing surface. Each of the roads is considered a Non-National Highway System (NHS) road with Functional Classifications ranging from Rural/Urban - Local to Rural Minor Collector.

This project in conjunction with the completed Bridge Maintenance I and Bridge Maintenance II will help to keep County Bridges in good condition.

The Legislature previously authorized \$185,000 (\$37,000 County Share) for the design phase of the project as part of a multi-year funding plan. The estimate to construct the project currently stands at \$1,350,000 and is scheduled for a 2019 letting.

This project will be a "LOCALLY ADMINISTERED FEDERAL AID PROJECT" with a financial cost breakdown for Construction of 80% Federal, 15% State, 5% County.

Improvements are proposed which will include all necessary guiderail, pavement, shoulder, drainage facilities, signing, striping and signal upgrades.

The Legislature previously authorized \$170,000 (\$34,000 County Share) for the design phase of the project as part of a multi-year funding plan. The estimate to construct the project currently stands at \$1,350,000 and is scheduled for a 2019 letting.

E. <u>Tuttle Road Bridge, C-218, BIN 3207960 over Tuttle Brook</u> – This project will design and construct the rehabilitation of the bridge on Tuttle Road, a Town of Cicero owned highway.

The bridge is in disrepair, and needs to be rehabilitated. The bridge superstructure needs to be replaced, and repairs made to the existing backwalls, pedestals, seats, and bearings. Concrete repairs will be made to the substructure elements. The bridge has a posted weight limit of 22 tons after the issuance of a red flag. Minor striping and delineation improvements on the approaches will be made where necessary.

The estimate to design and construct the project currently stands at \$1,710,000 and is scheduled for a 2019 construction letting. Additional construction funding is being programmed as part of the 2018 Workplan.

The Legislature previously authorized \$360,000 (\$72,000 County Share) for the design phase and \$350,000 (\$17,500 County Share) for the design of the project as part of a multi-year funding plan.

This project will be a "LOCALLY ADMINISTERED FEDERAL AID PROJECT" with a financial cost breakdown for design of 80% Federal, 20% County, and for construction of 80% Federal, 15% State, 5% County.

### TRAFFIC SYSTEMS MANAGEMENT

The Traffic System Management Program provides funds to upgrade safety and traffic mobility at various Onondaga County highway intersections.

<u>2018 Traffic Signal Upgrades</u> – The purpose of this ongoing program is to maintain and upgrade our existing system of over 100 three colored traffic signals.

The following intersections are scheduled for complete replacement:

- Jamesville Road at Nottingham Road.
- Thompson Road at Eastern Avenue.

The following signal is scheduled for a Detection System upgrade:

• Northern Boulevard at East Taft Road.

The following Flashing Beacon Signs are scheduled for replacement:

- Duguid Road at Salt Springs Road intersection warning signs (2 Each)
- Lakeshore Road curve warning signs (2 each)
- East Taft Road intersection warning sign (2 each)
- Warners Road curve warning sign (1 each)

### COLD MIX BITUMINOUS RECONSTRUCTION - See Attached Paving List on page 15

Beginning in 2007 and continued through 2016, 2017 and now 2018, the Department increased the use of "Pavement Preservation Techniques". These are lower cost initiatives whose goals are to prolong the life cycle of the highways. The idea of this program is to keep the highways which are presently in "good" condition in the same condition. In other words, keep the good roads good. These projects are marked with asterisks on the project lists. In 2018, the Department will continue to mimic the NYSDOT's "Forward Four" program by employing Pavement Preservation Techniques on at least 90% of our maintenance paving projects.

The Cold Mix Bituminous Reconstruction Program was instituted in 1980 to restore badly deteriorated highways on our approximately 375 mile long low volume highway system. Highways eligible for this program have deteriorated to the point where less expensive pavement preservation types and rehabilitation strategies would not be effective.

The work consists of the replacement of drainage pipes and structures as required, ditches are regraded and cleaned, the existing pavement is shimmed, milled or reclaimed, graded and compacted. Finally, a course of cold mix bituminous pavement and a bituminous surface treatment is applied to provide a roadway with a minimum ten year expected life span. See attached list on page 15.

Work will be accomplished by a combination of County and Contract forces in 2018.

# **LOCAL BRIDGES**

The following bridges will be replaced or repaired in 2018 and 2019. The County of Onondaga Department of Transportation has started preliminary design, and construction will be done in 2018 by County forces except where noted.

L. <u>Caughdenoy Road, C.R. No. 49, County Bridge C-16</u> - is located in the Town of Clay on Caughdenoy Road over Youngs Creek. The existing structure was built in 1965 and consists of a 20' x 34' concrete deck founded on concrete abutments and spread footings. The structure is in poor condition and is experiencing load rating deficiencies. The existing structure will be removed and replaced with a 25' x 8' Span precast concrete box culvert.

The Legislature previously authorized \$350,000 for the design and construction of this Bridge. The survey was completed by County personnel in 2015 and construction will be completed by Contract forces in the summer of 2019. The Department will utilize OTASC Tobacco Funds for this project.

ADDITIONAL PROJECT COST:

\$ 200,000

M. West Valley Road, C.R. No. 113, County Bridge C-206 - is located in the Town of Spafford on West Valley Road over a tributary to Spafford Creek. The existing 5' x 3' concrete box structure, built in 1938, has a poor condition rating and requires replacement. The existing structure will be replaced with an 83" x 57" Aluminized CSP Arch. The survey has been completed by County forces. Updated guiderail and approaches will be provided as part of the project.

The estimate to construct the project currently stands at \$190,000. Construction will be completed by County Forces in the summer of 2018. The Department will utilize OTASC Tobacco Funds for this project.

PROJECT COST:

\$ 190,000

N. Tully Farms Road over Blue Hole Creek, C.R. No. 234, County Bridge C-161, BIN 3312970 - is located in the Town of Lafayette on Tully Farms Road over Blue Hole Creek. The existing structure was built in 1972 and consists of a 40' x 34' concrete deck with concrete abutments founded on concrete footers. The existing structure has a low condition rating based on county inspections and requires rehabilitation. The concrete deck will be replaced and concrete work on the foundations will be required. It is anticipated that this project will be advertised for construction in the spring of 2019 with contract forces undertaking construction in the summer of 2019.

Survey and design of the project will be completed by consultant forces in 2018. The Legislature previously authorized \$255,000 for the design and construction of this Bridge. The Department will utilize OTASC Tobacco Funds for this project.

ADDITIONAL PROJECT COST:

\$ 280,000

O. <u>Caughdenoy Road over the Oncida River, C.R. No. 49, County Bridge C-18, BIN 3360460</u> - is located in the Town of Clay on Caughdenoy Road over the Oneida River. The existing structure was built in 1928 and the Concrete deck was replaced in 1986. The structure consists of 4 - 75' spans of reinforced concrete arches. This structure is owned jointly by Onondaga and Oswego Counties and as such the final cost will be evenly divided.

The project will rehabilitate of the 4 concrete arches and consists of removal and replacement of the arches concrete where needed.

The monies requested will provide for Onondaga County's portion of the design of the project and the construction funding. The total estimated cost is \$420,000 to complete construction. An estimated 2018 letting is expected. The Department will utilize OTASC Tobacco Funds for this project.

\$ 210,000

P. <u>County Bridge Repair, Stream Cleaning, Maintenance Cleaning and Sealing</u> - will be done on various structures as required for maintenance purposes and for repairs to elements on County bridges that do not meet the requirements for bonding.

PROJECT COST: \$ 140,000

# HOT MIX BITUMINOUS PAVING - See Attached Paving List on page 17

Beginning in 2007 and continued through 2016, 2017 and now 2018, the Department increased the use of "Pavement Preservation Techniques". These are lower cost initiatives whose goals are to prolong the life cycle of the highways. The idea of this program is to keep the highways which are presently in "good" condition in the same condition. In other words, keep the good roads good. These projects are marked with asterisks on the project lists. In 2018, the Department will continue to mimic the NYSDOT's "Forward Four" program by employing Pavement Preservation Techniques on at least 90% of our maintenance paving projects.

The Paving Program is reserved for the 477 equivalent lane miles of high traffic volume County highways. The Department of Transportation has determined that it is cost effective to periodically repave the wearing surface on its highways. This procedure extends the life of the roadway, thereby protecting the County's investment. The repaving procedure provides additional skid resistance and waterproofs the base. Prior to the resurfacing, many of these highways are first trued and leveled to restore a proper crown. The shoulders on all highways under this program are stabilized with asphalt concrete.

The program is funded with a combination of authorized borrowing and State funding through the CHIPS program. See attached list on page 17.

PROJECT COST: \$5,930,000

### **GUIDE RAIL**

This project is designed to upgrade existing substandard guide rail and install guide rail in various locations on county highways to improve safety and reduce liability. Work will be performed as a cooperative project by the Department of Transportation and contract forces.

PROJECT COST: \$250,000

### **BITUMINOUS SURFACE TREATMENT** - See Attached List on page 19

The annual bituminous surface treatment program is designed to preserve and extend the life of pavement on the County's low volume highway system. The intent is to treat eligible highways on a five-year rotation basis. At the very minimum, the Cold Mix Bituminous Paving projects included in this plan must be surface treated. See attached list on page 19.

PROJECT COST: \$1,250,000

### **TESTING**

The Department of Transportation began the development of its Pavement Management System in 1984. By 1987, the implementation of the program for high volume highways was completed with 428.75 miles in the system. An annual update program was instituted to maintain the accuracy of the database. In 1991, the update program continued, but with the budgetary problems plaguing county government, the Department was forced to look for more efficient ways to manage the limited funds available. It was felt that by incorporating the "secondary" county highways into the pavement management system, a savings could be realized in both the surface treatment and cold-mix paving programs. In 1995, the 375-mile secondary system was incorporated into the study.

In 2018, work will continue to update the secondary highway program together with the annual update of the primary highway pavement management program.

Funding shown includes other testing activities to be performed in 2018 including tests on aggregates, liquid bituminous materials, concrete and other materials used in highway and bridge construction.

PROJECT COST: \$ 100.000

# **DRAINAGE**

Storm sewer systems, catch basins and culverts will be installed and/or replaced at various sites on County highways in 2018 in an effort to maintain the pavement structure by insuring proper surface and subsurface drainage. Many of the corrugated steel pipe systems installed 30 and 40 years ago are deteriorating and are require replacement. New high density polyethylene (HDPE) pipe, with an almost unlimited lifespan is being installed in its place.

The Onondaga County Department of Transportation owns and maintains four highway maintenance facilities in various locations throughout the County. This funding will be used to perform capital repairs to these facilities.







AMENDING THE 2018 COUNTY BUDGET TO PAY IN THE FIRST INSTANCE 100 PERCENT OF THE FEDERAL AND STATE AID ELIGIBLE COSTS AT A MAXIMUM AMOUNT OF \$5,367,500 FOR THE ELECTRONICS PARKWAY 2R PAVING PROJECT, PIN 3755.71, AND AUTHORIZING EXECUTION OF AGREEMENTS

WHEREAS, a project for the Electronics Parkway 2R Paving Project, PIN 3755.71, funded for in Title 23 US Code, as amended, calls for the apportionment of the costs of such project to be allocated at the ratio of 80 percent federal funds (\$4,520,000) and 20 percent non-federal funds (\$1,130,000) for a total Project cost of \$5,650,000; and

WHEREAS, the State of New York requires Onondaga County to contribute up to 100 percent of the non-federal share of the construction phase of this project, and to pay in the first instance the total federal share of the cost of the construction phase; and

WHEREAS, State funds are available to cover 75 percent of the non-federal share of the project (\$847,500), and local dollars are available in previously appropriated DOT capital funds to cover the remaining 25 percent of the non-federal share (\$282,500); and

WHEREAS, the County of Onondaga desires to advance the project and to pay in the first instance the federal share of the costs for the above project, in addition to the non-federal share of the project costs, filing afterward for reimbursement of eligible costs; now, therefore be it

RESOLVED, that the County Legislature hereby approves the project, agrees to participate and pay up to 100 percent of the non-federal share of the project and agrees to pay in the first instance up to 100 percent of the total federal share of the project; and, be it further

RESOLVED, that the County Executive is hereby authorized to execute agreements to implement the intent of this resolution, providing for County participation in the cost of the local share of the project and for payment in the first instance of the remaining share of the costs; and, be it further

# LOCAL LAW NO. - 2018

A LOCAL LAW AMENDING THE ONONDAGA COUNTY CHARTER AND ADMINISTRATIVE CODE TO PROVIDE CLARIFICATION AND GUIDANCE RELATED TO THE COUNTY LEGISLATURE'S AUTHORITY TO HIRE OUTSIDE COUNSEL TO PROVIDE LEGAL SERVICES, INCLUDING THE PREPARATION OF LOCAL LAWS, ORDINANCES, RESOLUTIONS, LEGALIZING ACTS OR OTHER LEGISLATION

BE IT ENACTED BY THE COUNTY LEGISLATURE OF THE COUNTY OF ONONDAGA, AS FOLLOWS:

Section 1. Findings.

WHEREAS, the Onondaga County Charter (the "Charter") states that the County Attorney is the "sole legal advisor of the county" and for county officers and employees; and

WHEREAS, the Onondaga County Administrative Code (the "Code") states that the County Attorney shall "prepare local laws, ordinances, resolutions, legalizing acts or other legislation upon request of the County Executive or a member of the County Legislature, together with notices and other documents in connection therewith"; and

WHEREAS, there may be unique situations where the County Legislature, through its Chairman, determines that the County Attorney, who is appointed by and serves at the pleasure of the County Executive, may have competing interests in preparation of local laws, ordinances, legalizing acts or other legislation; and

WHEREAS, the County Legislature is the policy determining body of the County and is vested with all of the powers of the County, including the authority to amend the Charter (Article XXII, Section 2202, Charter) and the Code (Article II, Section 208 Charter) (see also the Doctrine of Separation of Power and the power granted by New York State to local governments to adopt and amend local laws and ordinances under the New York State Constitution (see Article IX, §1 and §2c); Statutes of Local Governments (Article 2, §10); Municipal Home Rule Law (see §10, §10(b) and §33); and

WHEREAS, it is the desire of the County Legislature to make it clear that the Charter and the Code as drafted authorizes the Chairman to consult with and use outside counsel to provide the County Legislature with legal advice, including the preparation of local laws, ordinances, legalizing acts or other legislation; now, therefore be it

RESOLVED, that the following local law shall be enacted:

Section 2. Outside Counsel.

(a) Article VII, Section 702 of the Onondaga County Charter is amended to add the following italicized language:

Section 702. POWERS AND DUTIES.

Except as otherwise provided in this charter, or the administrative code, the county attorney shall be the sole legal advisor for the county and, on its behalf in county matters of a civil nature, advise all county officers and employees and, where in the interest of the county, prepare all necessary papers and written instruments in connection therewith; prosecute or defend all actions or

proceedings of a civil nature brought by or against the county; prepare resolutions, ordinances, legalizing acts and local laws to be presented for action by the board of supervisors, together with notices and other items in connection therewith; and perform such other and related duties as may be prescribed by law, by the county executive or by resolution of the board of supervisors. Nothing contained herein shall prohibit the Chairman of the County Legislature, upon a finding by the Chairman that a conflict of interest may be present or that it is in the best interest of the County Legislature, from using outside counsel or a specifically designated Legislative Counsel to provide legal assistance, including, but not limited to, the preparation of resolutions, ordinances, legalizing acts and local laws to be presented for action by the County Legislature, the successor in interest of the board of supervisors. Such outside counsel or specifically designated Legislative Counsel may seek the advice of the county attorney as to form and legality in the preparation of resolutions, ordinances, legalizing acts and local laws.

#### Section 3.

- (a) Article VII, Section 7.02 of the Onondaga County Administrative Code is amended to add the following subsection (f):
  - (f) Nothing contained herein shall prohibit the Chairman of the County Legislature, upon a finding by the Chairman that a conflict of interest may be present or that it is in the best interest of the County Legislature, from using outside counsel or a specifically designated Legislative Counsel to provide legal assistance, including, but not limited to, the preparation of resolutions, ordinances, legalizing acts and local laws to be presented for action by the County Legislature. Such outside counsel or specifically designated Legislative Counsel may seek the advice of the County Attorney as to form and legality in the preparation of resolutions, ordinances, legalizing acts and local laws.

# Section 4. Severability.

If any clause, sentence, paragraph, section or part of this local law shall be adjudged by a court of competent jurisdiction to be invalid, the judgment shall not affect, impair or invalidate the remainder hereof, but shall be confined in its operation to the clause, sentence, paragraph, section or part thereof directly involved in the controversy in which the judgment shall have been rendered.

Section 5. Effective Date.

This local law shall be effective immediately upon filing, consistent with the provisions of the Municipal Home Rule Law.
